ER::5K participants meet at Platte Canyon High School, parking near the football field on the south side of U.S. Highway 285. Runners and walkers will be shuttled to the starting point.

Register and check in near the parking area between 9:00 and 10:30 a.m. The Run begins at 11:00, ending at Platte Canyon High School where lunch and refreshments will be available.

The ER::5K coincides with The 4th Annual Emily's Parade Ride - a motorcycle ride beginning at Columbine High School. Both the Run and the Ride will ultimately converge at Platte Canyon High School where lunch and refreshments will be available.
